Kiva Update

Ella Ryder and I connected to select the recipient of our next Kiva loan. Our branch has decided to relend the \$175 returned to us by the group of women in Senegal. We decided to support Soeun, a 59year-old mother of 10 in Kampong Cham province, Cambodia. Soeun still has two children at home who attend school. Her other children are either factory workers or help her with the family business which is rice farming. Soeun joined VisionFund Cambodia, Kiva's field partner and has successfully repaid a previous loan used to improve her life. She is requesting a second loan to buy fertilizer for her farmland and to build a new latrine. She has been in business for 20 years to feed her big family. She earns about \$6 (US) a day.

Kiva's field partner, VisionFund Cambodia (VFC) is a 4 star (out of 5) microfinance banking organization that is noted for its impact on poverty and transparency. This agency has a strong emphasis on poverty outreach focusing on the poorest rural areas within Cambodia. Full payment is due September 2013.

At the time Ella and I were online, Soeun needed another \$175 to complete her loan. So our donation completed her funding request. We would like to thank all of you for your continued support. The following two news items were contained in a list of Public Policy topics that I recently received in the AAUW Washington Update.

Men Still Surpass Women in Political Donations

Men give more than two-thirds of all itemized political donations (those greater than \$200) despite being outnumbered by women in the U.S. population and among voters. During the 1990 election cycle, women gave 24 percent of the total \$151 million in itemized donations to congressional candidates. In 2008, the percentage of female donations rose to 28 percent of the \$641 million total contributions. At that rate of growth, women will not have equal influence via political donations until the 2110 midterm elections.

Global Gender Pay Gap Unchanged in Last Decade

A new report by the International Trade Union Confederation found that women are paid 18 percent less than men on average worldwide. The report, Frozen in Time: Gender Pay Gap Unchanged for 10 Years, analyzed women's wages in 43 countries and concluded that no significant progress had been made in closing the global gender pay gap for more than a decade. The report found that workers in traditionally unionized sectors tend to fare better in terms of the gender pay gap. The report also showed that childrearing is much more detrimental to female wages than to male wages.

I found both of these articles very interesting primarily for the reason that if you take into consideration the disparity in the pay gap it stands to reason that women have less disposable income than their male counterparts to donate to political candidates and/or parties. Even though the Gender Pay Gap article is addressing that problem on a global scale the fact remains that the pay gap is still – unfortunately – alive and well in the United States despite the best efforts of those who would see that corrected.

Perhaps with the upcoming elections now, more than ever before, it would behoove us all to take some time to explore the voting records of our elected representatives with relation to gender pay gap legislation before we make a decision as to where to cast our vote. Women fought to obtain the vote for many reasons – pay equity is only one of them – but, it is one that continues to remain elusive. --Helen Martin

13th Sister to Sister Summit

Thanks to the dedication of our AAUW members, our branch will be offering this wonderful conference for girls in grades 6-8 for the 13th year!

Registration packets have been sent to middle schools in the tricounties for our 13th annual Sister to Sister Summit which will be held on May 22 at FMCC. Fifteen students from each school will be invited to attend the event. Registration will be handled by the schools.

This year's summit which is chaired by Linda Bumpus and Patsy Suydam will feature a Tech Savvy theme to focus on topics designed to encourage girls to explore STEM opportunities: Science, Technology, Engineering, and Math. Studies show that after middle school, girls often become disinterested in science and math courses. High school girls tend to enroll in science courses at lower levels than their male counterparts. The workshops offered this year are all designed to show that math and science can be fun and interesting. At Sister to Sister, participants will meet interesting professionals, most of them from the FMCC staff.

Thirteen faculty members from FM will provide the workshops which involve using math and science. Robotics, forensic science, medical diagnostics, theater technology, DNA exploration, and introduction to the nanotech clean room will be included in the sessions. Three of the workshops will be facilitated by faculty members

John Kohn, Sonnet Gravina, and Sherry Warner who are also AAUW members. AAUW member Laurie Freeman, Associate Professor of Science and Science Division Chair at FM, will be the capnote speaker and will highlight the theme with a talk entitled: Tech-Savvy and Ready for Anything! Sister to Sister committee members Mary Ann Abad and Anne Campos have been busy securing donations of snacks for the event. Melanie Pombrio and Sue Summerfield are handling registration.
