The ladies have been working hard pulling together ideas and programs for our meetings. Paula Lerner and Darcelle Winchell, Thank you for being our Program VPs and to all of the members who have helped in the planning. We thank everyone who had submitted their survey responses. Your suggestions were taken into consideration in this year's planning. One of the things noted was the price for the meetings. August 19th was National Aviation Day. Our National AAUW website had a blog posted by Christie Jones, CAE. She had listed the various women aviation leaders from the start of aviation to current day. The blog made me think of Wally Funk who was here a few years ago. Helen Martin invited Wally to the area to meet with our branch and with area school students. In February 1961, at the age of 21 Wally volunteered for the "Women in Space" Program with an independent clinic which had the support but not the official sponsorship of NASA. Only twenty-five women were chosen for testing. Wally underwent a series of rigorous physical and mental tests and passed with a very high average, rating 3rd in the field of 13 qualifying candidates. It was at that time that Wally became fully absorbed with the idea of becoming an astronaut and traveling into space. The Ninety-Nines' website doesn't note the result of this women's program, but the women had surpassed the tests that were also given to their male counterparts. The Program was disbanded as it was felt that women should not participate in the space program. During her visit here she spoke of her next goal of being able to fly in a Virgin[®] Galactic Spaceship. I wonder if she is going to be able to finally get up into space.

At the end of our newsletter is a crossword puzzle that I created. It is not the Wall Street Journal level of expertise. It was something that I was playing around with this summer. The answers are printed at the end of the newsletter.

"Who is Working the Polls"

Elections are time consuming and expensive. They take a lot of planning, arranging and manpower in order to achieve a successful result. One of the most important positions within an election is the "Poll Worker". Their job is to ensure that every registered voter within that assigned district that walks through the polling site door is given an "EQUAL opportunity to "VOTE". This is a very important position and without poll workers election cannot proceed forward in the manner as they have in the past.

Poll workers are paid a non-taxed fee to compensate them for their time. For the most part, poll workers are assigned a poll site within their own district. There is a minimal amount of training that the poll worker is required to complete and they are paid for that time as well.

Most adults under the age of 62 are in the workforce and have obligations that prohibit their ability in becoming a poll worker. Therefore the average age of a poll worker is between 62-82.Most poll workers dedicate a number of years to the election process and become part of the counties election poll worker team. Although elec-

tions do not happen often, being a poll worker is not easy. The hours are long during an election time and the public can be unkind.

Most counties are not aware of the options that are available to communities for recruiting poll workers under retirement age. Listed below are just a few.

- 1) "Fundraising" for example is one of the ways that local organizations, groups and any non-profit agency or program can contribute manpower to the election process as well as raise money for their group or cause.
- 2) "Educational Purposes" where students can partake in the election process as a poll worker and learn about the voting process while earning education credit.
- 3) "Company Involvement" is a great way for companies to get involved in the community and allow their workers primary and election days off, without consequences. Instead, the companies give incentives to their staff to become election poll workers. The money the poll worker earns can be given to a charity or chosen group.

The lack of poll workers has been an issue for some time. Without poll workers the election process cannot move forward and will "CHANGE". All that women have fought so hard to gain could be lost. It has taken women many years of hard work and sacrifice to gain the right and privileged in "VOTING". Do we want an opportunity for that to be challenged and altered because of a technicality? I think NOT!

If there is anyone interested in becoming a poll worker please contact your local Election Board. We need YOU!!

Former athletic department professionals allege unequal pay practices, retaliation

The American Association of University Women <u>Legal Advocacy Fund</u> announced today that it will provide support to the plaintiffs in *Moshak v. University of Tennessee*, a case that underscores the everyday nature of gender discrimination in college athletics.

The lawsuit was filed in 2012 by Jennifer Moshak, Heather Mason, and Collin Schlosser, former employees of the University of Tennessee's women's athletics department. The plaintiffs allege sex discrimination and unlawful retaliation under Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and the

Equal Pay Act of 1963. They claim they were unlawfully discriminated against and eventually forced out of their positions during a university-led merger of the men's and women's athletic departments.

Schlosser and Mason argue in part that they were fired by UT after making internal complaints alleging unequal pay between the men's and women's athletic departments. Moshak claims she was forced to retire after being demoted and marginalized. The plaintiffs also say that during the merger, which was led by newly hired Athletic Director Dave Hart, the vast majority — 86 percent — of positions terminated either were held by women or were associated with the women's athletic department.

"This case is an opportunity to grapple with some of the gender gaps still at play in university athletics," said AAUW Executive Director and CEO Linda D. Hallman, CAE. "We are proud to stand with these plaintiffs in their fight for fairness. Their claims shine a light on why AAUW does this type of work, day in and day out."

The case is currently scheduled to go to trial in June 2015 in the U.S. District Court for Eastern Tennessee.

"The University of Tennessee and its Athletic Director Dave Hart engaged in blatantly discriminatory and retaliatory actions against accomplished employees in the women's athletic department, in violation of Title IX and other federal laws," said the plaintiffs' attorney, Lisa Banks, of Katz, Marshall, and Banks, a civil rights law firm in Washington, D.C. "Gender discrimination is unfortunately a situation that is all too common in collegiate athletic departments across the country today, and we intend to use all the tools at our disposal to hold the university accountable and to shed light on this pervasive problem."

The AAUW Legal Advocacy Fund has been crucial to the success of <u>many gender discrimination cases</u> during its 33-year history. The <u>case support program</u> provides financial and organizational backing for plaintiffs challenging gender discrimination in education and the workplace. The funds come directly from the generous contributions of AAUW members.

Last Time: August Lunch Bunch Book Discussion

Six members met for lunch at Mt. Fuji Japanese Restaurant to discuss the book "In the Shade of the Banyan Tree". Photos taken by Patsy Suydam during her travels to Cambodia were shared by the group. The group also discussed the timeliness of reading the book since it was noted that an article regarding the subject had just been on the front page of the local newspaper on August 8. The article was about the very recent UN backed tribunal that sentenced two top leaders of the former Khmer Rouge Cambodian regime to life in prison for crimes against humanity during Cambodia's reign of terror in the 1970's that left close to 2 million people dead. Under the Khmer Rouge there was a forced exodus of millions of people from Cambodia's town and cities and a mass killing. Many died though starvation, medical neglect and overwork while building earthen walls against the monsoons and planting rice. The author of the book and her family had experienced it all.

The Woman Who Changed Her Brain: And Other Inspiring Stories of Pioneering Brain Transformations by Barbara Arrowsmith-Young and Norman Doidge, MD.

Barbara Arrowsmith-Young was born with severe learning disabilities that caused teachers to label her slow, stubborn or worse. As a child, she read and wrote everything backward, struggled to process concepts in language, continually got lost, and was physically uncoordinated. But by relying on her formidable memory and iron will, she made her way to graduate school, where she chanced upon research that inspired her to invent cognitive exercises to "fix" her own brain. *The Woman Who Changed Her Brain* interweaves her personal tale with riveting case histories from her more than 30 years of working with both children and adults.

The Woman Who Changed Her Brain powerfully and poignantly illustrates how the lives of children and adults struggling with learning disorders can be dramatically transformed. This remarkable book by a brilliant pathbreaker deepens our understanding of how the brain works and of the brain's profound impact on how we participate in the world. Our brains shape us, but this book offers clear and hopeful evidence of the corollary: We can shape our brains.




