### LAF UPDATE

AAUW is "profoundly disappointed" in the recent ruling of the Supreme Court on the *Wal-Mart vs. Dukes* case. In June, the Supreme Court announced that the case was simply "too large." They chose to ignore more that 40 years of established jurisprudence and now have restricted workers fighting gender discrimination through a class action suit. Each woman has the ability to file a claim as an individual.

The ruling of the Supreme Court in this case does **NOT** determine the guilt of Wal-Mart. It merely says that they do not have the right to address gender discrimination through class action suits. As you can imagine, this has far reaching effects in workplace discrimination suits.

AAUW is not giving up. AAUW Public Policy Director Lisa Maatz says, "The Supreme Court has been wrong before – just ask Lilly Ledbetter."

#### My Sister's Keeper Disbursement

Most of the members at our September meeting voted to split the proceeds of the Equal Exchange fundraiser. So we are sending \$180 to the Fistula Foundation and \$175 to Kiva. Michelle and I selected a group of 13 women from Senegal, Africa to loan the money to. They will be using the funds to expand their store that sells incense and perfume. Maty the coordinator of the group has been in business for a year and a half and she and her husband have 5 children. Senegal is a very poor country and our donation has (as of this writing) put the group at 56% funded. In addition to those tasks, Janice also manages several out-reach programs for the school district. She is a member of the Sacandaga Valley Arts Network, the Mohawk Harvest Cooperative, and the Knitty Bitty knitting group. She enjoys nature photography, knitting, reading and cross country skiing. Janice, who was invited to join AAUW by Carol Cownie, is very interested in supporting women's issues.

Ann Thane considers her election to Mayor "a gift" and has laid out an ambitious plan to protect and advance the interests of the Amsterdam taxpayers. She is involved in organizations that would fill our page and has received honors and awards from the Montgomery County Chamber of Commerce, the Upstate History Alliance, and the Montgomery County Democratic Star Award. Prior to being elected mayor, Ann has been the Director at Walter Elwood Museum, a Freelance Graphic Artist in Amsterdam and has worked as Assistant Art Director. and Art Director at various other firms from New Jersey to Albany. She was very actively encouraged to join our AGJ branch by Liz Russo. Ann has a degree from the University of Delaware in Fine Arts & Art History and is very interested in working with our branch to help and support AAUW.
